## ARTICLES OF INCORPORATION

SIXTH: Notwithstanding any other provision of these Articles of Incorporation, or the Code of Regulations, the Corporation shall neither exercise any powers nor conduct any activities which are prohibited to: (a) a corporation exempt from federal income tax under Section 501(c)(3) of the Code; or (b) a corporation to which contributions are deductible under Section 170(c)(2) of the Code.

**SEVENTH:** The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including (for such purposes) the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code or corresponding section of any future federal tax code.

**EIGHT:** No part of the Corporation's net earnings shall inure to the benefit of or shall be distributed to its Members, Directors, Officers or any other private individuals, except that the Corporation may pay to such persons reasonable compensation for services rendered and, further, may make payments and distributions to such persons in furtherance of the Corporation's exempt purposes as stated in Article THIRD, above.

NINTH: The powers of the Corporation shall be exercised, its business and affairs conducted and its properly managed under the direction of the Board of Directors of the Corporation, except as otherwise provided by the laws of the State of Ohio, these Articles, or the Corporation's Code of Regulations. The number and manner of selection of Directors shall be determined by the Corporation's Code of Regulations.

**TENTH:** The Corporation may be dissolved upon a majority vote of the Directors, provided that upon dissolution the Corporation, after paying or making provision for the payment of all the liabilities of the Corporation, must distribute its assets exclusively for the purposes of the Corporation in such manner, or to such organization or organization organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify

as an exempt organization or organizations under Section 501(c)(3) of the Code as the Board of Directors shall determine.

ELEVENTH: No substantial part of the Corporation's activities shall be to carry on propaganda, to attempt otherwise to influence legislation, or to participate or intervene in (including to publish or to distribute statements) any political campaign on behalf of any candidate for public office. The corporation shall not engage in any activities which will characterize it as an "action" organization under Section 501(c)(3) of the Code.

TWELFH: The Corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in the manner now or later prescribed by statute; provided, however, that no such amendment, alteration, change or repeal shall affect the public benefit nature of the corporation.
